Pursuant to the provisions of the National Government Constituencies Development Fund Act, CAP 414A Laws of Kenya, sections 43(1), (2), (3) and 57(1) and its Regulations, Soy Constituency – National Government Constituency Development Fund invites members of the public to submit written applications for membership to the National Government Constituency Development Fund Committee for Soy Constituency.

Pursuant to the NG – CDF Regulations, 2016 the NG – CDF Fund Account Manager declares the following vacancies;

Eligible applicant should be:

1. A Kenyan citizen;
2. A resident voter in the constituency;
3. Is holder of a Kenya Certificate Secondary Education (KCSE) or equivalent;
4. Meet the requirement of Chapter Six of the Constitution of Kenya;
5. Is available on short notice to participate in activities of the constituency committee; and
6. Not a serving public officer or servant.

Interested applicants are required to submit their applications in writing addressed to the Fund Account Manager, Soy Constituency NG - CDF, indicating vacancy number, attaching copies of testimonials for the above requirements, clearance certificates from Kenya Revenue Authority, Director of Criminal Investigations, and current Certificate from a Credit Reference Bureau and Ethics and Anti – Corruption Commission to reach the undersigned on or before Wednesday December 23rd, 2024 at 1700hrs. The applicant must declare in their application letters to the effect that they are not serving public officer or servant.

Two of the available positions are reserved for youth of either gender and therefore relevant qualified constituents are encouraged to apply.
